ORDER

It is an continuation of the sanction order no. F.no. 1(80)/DM(W)/DUDA/MLA LAD/ 2015-16-639-644 dt. 31.03.2016 vide which 50% amount i.e. Rs.12.45.850/- of estimated amount Rs. 24.91.700/- was released vide order no. mentioned above.

During scrutiny of the estimate some correction was made and the 50% amount i.e. Rs. 15.31.300- of the estimated amount Rs. 30.62,000/- was to be released.

Now the difference between already released amount of Rs. 12,45,850/- and re-calculated 50% i.e. Rs. 15,31,000/-, Rs. 2.85,150/- is being released in addition to Rs. 12,45,850/-.
