ORDER

I am directed to convey the sanction of Chairman DUDA West Delhi in In pursuance of directions received from Divisional Commissioner during a meeting held under the chairmanship of Hon'ble Deputy Chief Minister on dated 10.03.2016 which was circulated vide no. 36 (74) Coordn/Div Comm/2015/7115 dated 11.03.2016, in which 50% of the estimate amount is allowed to be released to the all executing agencies subject to the conditions that the work will be completed in all respect and quality of work will also be certified by an appropriate third party and that the concerned agency shall also furnish the utilization certificate after completion of work, to carry out the following works in Assembly Constituency No. 11 of Hon'ble MLA Sh. Raghuvinder Shokeen, under the MLA LAD Scheme during the year 2017-18 as per details given below:-

The A/A and E/S of above works of amount **Rs. 7,47,500/- (Rupees seven lakh forty seven thousand five hundred only)** which is 50% of the total estimated amount i.e. **Rs. 3,73,750/- (Rupees three lakh seventy three thousand seven hundred fifty only)** is being released now for the above mentioned works in Assembly Constituency No.11, Nangloi Jat for the year 2017-18 during 6th Vidhan Sabha. The cheque/RTGS may be released in f/o of Commissioner North DMC.

The Release of funds vide this sanction is subject to the following conditions: -

1. The Executive Agency will obtain all permission and approval from respective agencies wherever required, before the start of work, special care need to be taken in respect of permanent structure in and around any water body and necessary approval may be obtained before start the work from competent authority.
2. The executing agency will ensure that work shall be carried out as per CPWD Specifications 1996 Vol-I & II and CPWD works manual with up to date correction slips.

20. The progress of works will be monitored by Revenue Department, both in physical and financial terms on monthly basis furnished by executing agency and reports furnished to Urban Development Department and Planning Department on quarterly basis.
21. The Assistant Engineer (DUDA) will visit the site where the work is to be carried out before starting the work and after completions the work by the contractor, for satisfactory completion of work.
22. The executing agency will ensure completion of work within target date of completion submitted by them.
23. Further 2nd installment of 30% to be released after 50% of work progress and last installment of 20% to be released after completion of work and submission of U.C.
24. The executing agency shall be responsible for conducting **IIIrd party quality control inspection**. The final payment shall be released only after receipt of work satisfaction report from IIIrd party quality control.
25. The executing agency shall be responsible to ensure that the proposed work is **not under defect liability period of earlier work done on the same site**.
26. If the cost of execution of the work is less than the sanctioned amount, the Executive Engineer concerned shall be responsible for refund the balance amount to DUDA (West) within 7 days after completion of the work.

The expenditure to this account is debitable to the DUDA Account for MLA AC-11 during the financial year 2017-18.
