Rajesh Rishi, under the MLA LAD Scheme during the year 2016-17 as per details given below:-

The A/A and E/S of above works of amount Rs. 5,08,600/- (Rupees Five Lac Eight Thousand Six Hundred Only) which is 50% of the total estimated amount i.e. Rs. 2,54,300/- (Rupees Two Lac Fifty Four Thousand Three Hundred Only) is being released now for the above mentioned works in Assembly Constituency No.30, Janakpuri for the year 2016-17 during 6th Vidhan Sabha. - 6. The Executive Agency will inform to District Urban Development Agency West at the time of execution of work and after 70 % of the completed with Quality Assurance and Technical Audit
- 7. No diversion of fund from one scheme to another is allowed without approval of Government of NCT of Delhi.
- 8. The Plan fund shall be subject to detailed scrutiny by Government of NCT of Delhi.
- 9. The audited accounts and utilization certificate for the year 2015-16 along with expenditure statement duly certified by the audit should be submitted as per GFRs.
- 10. Plan funds under the MLA local Area Development Scheme are utilized by the agencies strictly. in accordance with the parameters of the scheme on approved item of the work as amended from
- 11. The expenditure reported by various agencies (area wise) under MLA LADs shall intimate to the DUDA (W) for achievement reports both in physical and financial term on monthly basis.
- 12. The implementing agency will be responsible for technical scrutiny and approval of detailed
- 13. Location of the proposed work has to be checked by the executing agency and ensure that it is not located in unauthorized colonies.
- 14. The implementing agency should observe the provisions of GFRs for execution & award of the work, similar nature of work should be treated as single project.
- 15. As per section 3 of Delhi Geospatial Data Infrastructure (Management Control to the Administration, Security and Safety Act 2011) it is mandatory to upload various Geospatial Data attributes and Geospatial Database. Hence the same should be uploaded as works done under the MLALAD FUND on Geospatial Data of your Department.

- 18. The executing agencies under DUDA will upload on their websites full details of sanctione works, specifications, date of start and completion of the works, name of contractor and total amount of contract relating to MLALAD Funds separately for Mandatory Funds released time
- 19. As per Urban Development Department Order No. 18B(52)/UD/Plg./MLA/Misc.2008-09/875 8796 dated on 18.06.2010 Para 14, DJB, NDMC & DCB will issue sanction orders for developmental works as per the Guidelines of MLALAD Scheme regarding the Mandatory Fu and monitor its progress regularly. They will submit the monthly expenditure report and annu utilization certificate to the Urban Development Department, GNCT of Delhi.
- 20. The progress of works will be monitored by Revenue Department, both in physical and finance terms on monthly basis furnished by executing agency and reports furnished to Url Development Department and Planning Department on quarterly basis.
