1. Reasons for air pollution in Rajouri Garden.

The participants discussed several contributing factors including increased vehicular emissions.

- a) There are various construction activities in Rajouri Garden area due to this dust pollution be increased.
- b) Secondly, seasonal burning of waste and agricultural residue.
- c) Thirdly, industrial emissions from nearby areas.

2. Formulation of action plan to mitigate air pollution during winter 2024.

- a)** Enforcement of stricter pollution control measures for vehicles emissions
- b)** Promotion of public transport and carpooling initiatives.
- c)** Implementation of dust control measures at construction sites and regular monitoring of construction sites for compliance
- d) increased** awareness campaigns regarding waste disposal, collaboration with local agencies to monitor and prevent open burning of waste.
- e) involvement** of local residents in cleanliness drives.
- f)** Educational workshops on the impact of air pollution and preventive measures.

The Chairman emphasized the collective responsibility of all the stakeholders in combating air pollution and urged for immediate action. Heaters were distributed to the member of RWA for the night use for Guards.

The meeting ended with vote of thanks to Chairman and with a commitment to implement the proposed solutions effectively.
