Subject: **Non-production of election expenditure records for inspection**

The following scheduled dated for inspection of your election expenditure records at Room No. 405, 4th Floor, Office of the RO/DEO (West), Plot No.3, Shivaji Place, Raja Garden, New Delhi-110027 was communicated vide General Notice No. F.18(763)DEO 9West/Advertisement/2024/1043 dated 11.05.2024 published in Time of India (English), Hindustan (Hindi) Dainik Jagran (Hindi) and Indian Express (English).

Further, It was informed to you by email as well as on whatsapp that 1st inspection of election expenditure register was scheduled on 13.05.2024 at Room No. 405, 4th Floor, Office of the RO/DEO (West), Plot No.3, Shivaji Place, Raja Garden, New Delhi-110027.

Whereas, despite above efforts, you or your authorized election expenditure agent failed to present your election expenditure records – on 13.05.2024 during 10:00 hrs. to 17:00 hrs.

Further, as per Para on the subject of 'Inspection of Accounts' below Part-'C' with topic name 'Role of RO, DEO and CEO in expenditure monitoring' in the manual of 'Compendium of instructions on Election Expenditure Monitoring-2024', it is stipulated that – "If a candidate or his agent does not produce his Election Expenditure Register for inspection on the day fixed for this purpose, a notice shall be issued to the candidate by the RO in writing, informing him that if he fails again to produce the Register for inspection on the day specified in the notice, it shall be presumed that he has failed to maintain a day to day account of election expenditure as required under Section 77 of RP Act 1951. This notice shall be given the widest possible publicity and a copy shall be displayed on the notice board of the RO. If, in spite of the notice, the candidate fails to produce the register of election expenditure for inspection, a complaint under Section 171-I of IPC shall be filed in the competent court. Besides this, the permission given to the candidate for use of vehicles during election should be withdrawn, if the candidate does not produce the

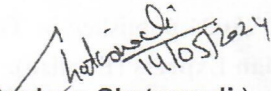
register after three days of service of the notice. The withdrawal of permission for use of vehicles shall be intimated to all the Surveillance Teams and Flying Squads and displayed on the notice board".

It is pertinent to mention herewith that as per Para-4 below Part-'A' with topic name 'Election expenditure monitoring – introduction and related legal provisions' in the manual of 'Compendium of instructions on Election Expenditure Monitoring-2024', it is stipulated that – ".....Failure to maintain the account is an electoral offence under Section 171-I of the Indian Penal Code read with other relevant legal provisions of the Representation of the People Act, 1951 ; the Conduct of Election Rules, 1961 ; etc.

Hence:-

- (a) Provisions bestowed in above Para is invoked and Notice is hereby issued **explaining the situation & consequences of non-production of election expenditure records for inspection.**
- (b) Also, an opportunity is given for presentation of your election expenditure records – for inspection immediately.

This issues with prior approval of DEO(S).

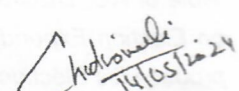
