Order (Under Section 133 of Cr.PC)

Whereas, the National Commission for protection of Child Rights (NCPCR) in collaboration with Narcotics Control Bureau (NCB) has prepared and released a Joint Action Plan on "Prevention of Drugs and substance Abuse among Children and Illicit Trafficking"

Whereas it is imperative to issue necessary direction to all the Medical Shops who selling the schedule "H", "H1" and "X" drugs for monitoring their sale.

Therefore, I, **Kinny Singh**, **IAS**, District Magistrate, District-West, Delhi in exercise the power conferred upon me under Section 133 Cr. P.C hereby direct the following for strict compliance.

- 1. All the Medical Stores / Chemist / Pharmacy shops under the jurisdiction of District West, Delhi who selling schedule "H" "H1" and "X" drugs are hereby directed to install CCTV Camera inside and outside their shops.
- 2. Time period of one month is being given to all the Medical Stores / Chemist / Pharmacy shops owner for installation of CCTV cameras footage of such cameras can be randomly checked by the District Drug Controller Authority/Child Welfare Officer/Police Officer at any time.
- 3. In case any Medical shop owner fails to comply with these directions, appropriate legal action shall be taken against his/her.

Concerned officer shall execute this order with the respective jurisdiction with the help of Police & Drugs inspector and submit their reports accordingly.
