The Chairperson directed that all SDMs shall officially communicate with the Nodal officers of Delhi Jal Board as per the order No. DJB/Addl. CEO/NGT/2024/3111 dated 24/01/2024. It was further directed that SDMs shall draw the proceedings of the sealing of bore-wells and a copy of the same should be sent to the Nodal officers of DJB as well as to DPCC.

During the meetings the SDMs informed that in some areas there is huge public resistance when they go for sealing of the illegal bore-wells. It was directed that a report on the same shall be prepared and signed by the all the members present at the time of sealing. Further, a copy of the same shall be provided to DJB who after technically examining shall bring the proposal for a fresh borewell in DAC in that area so that the illegal borewell can be sealed and compliance of the orders of Hon'ble NGT can be made.

It was also decided that the Executive Engineer of the concerned area of DJB shall remain present during the sealing of illegal bore-well and Delhi Police shall provide adequate security during sealing of the illegal borewells.

It was directed by the Chairperson that a fresh report shall be prepared by all the three Sub Divisions and the same shall also be signed by the concerned Executive Engineers present in the meeting. However, it was observed that the Executive Engineers left the office without signing the report.

The meeting ended with a vote of thanks to the Chair.

At the outset the Chairperson welcomed all the members present in the meeting. No representative was present from DPCC and the Chairperson has taken a strong view regarding the absence of DPCC in the meeting as the EDC is to be imposed and recovered by DPCC on the illegal borewells sealed. It was directed that DPCC shall attend the meetings as and when scheduled.

The action taken report was sought from the DJB on the directions issued in the last meeting held on 16.10.2023. It was informed that a joint visit of the officials of DJB and CGWA was done on 19.01.2024 for the 11 borewells of AC-25, Moti Nagar Constituency, however, the report is yet to be prepared. It was directed that the report may be prepared at the earliest.

The other officers present in the meeting in respect of whom the proposals were deferred informed that no joint visit could be done with CGWA officers. It was directed to take necessary action regarding the joint visit and a report be submitted at the earliest.

Thereafter, the matter regarding implementation of the Orders dated 04.12.2023 of the Hon'ble NGT in M.A. No. 24/2023 in O.A. No. 33/2022 was discussed.

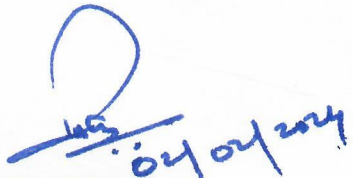
Sh. Dalbir Singh, S.E. (M-8) informed that as per the orders of Hon'ble NGT, out of 2185 illegal borewells identified by DJB in Distt. West, action has been taken on 1793 borewells and 392 are yet to be sealed.

The Chairperson directed that all the concerned departments should come together for implementation of the orders of Hon'ble NGT and the DJB will help SDM Office in sealing the illegal borewells. It was also decided that for sealing of illegal borewells, atleast a J.E. rank officer from DJB shall accompany the officers of Revenue Department.

It was also decided that DPCC should take necessary steps in recovery of the pending EDC amount from the defaulters as per law.

Sh. Dalbir Singh, S.E. (M-8) requested that another meeting may be held on 25.01.2024 to take the progress on sealing of illegal borewells so that prepare the reply to be submitted in the Hon'ble NGT.

Meeting ended with a Vote of Thanks to the Chair.
