ORDER

Whereas an order had been issued by this Tribunal vide No. ADM(W)/Sr. Citizen/2010/712 dated 22/02/2012 in respect of an application filed by Shri R. K. Ratti S/o Late Shri Baij Nath Ratti and Smt. Kamal Ratti W/o Sh. R. K. Ratti R/o Wz-80, Prem Nagar, Uttam Nagar, New Delhi-110059 under the Maintenance and Welfare of Parents and Senior Citizens Act, 2007, whereby both the sons of the applicants, Shri Ranjan Ratti and Shri Chandan Ratti were directed to pay Rs. 5000/- (Rupees Five Thousand Only) each every month into the saving account no. 10483572597 of SBI, Uttam Nagar, New Delhi held in the name of Smt. Kamal Ratti by 10th day of every month.

And whereas it has been brought to the notice of this Tribunal that both the sons have not yet started depositing the said amount into the said bank account and also that the younger son of the applicants Shri Chandan Ratti has locked the kitchen thereby restricting the elderly applicants from using water etc. even though the property is held in the name of the applicants and that the younger son Shri Chandan Ratti is constantly giving mental and physical torture to his parents/ applicants herein.

Now, therefore, this Tribunal directs both the sons again to start paying Rs. 5000/- (Five Thousand Rupee Only) each per month to the applicants immediately and also that the kitchen shall be kept opened all the times, failing which necessary action as per law would be initiated against both the sons.

Ordered accordingly.
