After approval of LAC, Account Clerk will prepare the cheque in favour of applicant alongwith the following documents and send the file again to LAC through NT (LAC)/Tehsildar (LA)for signatures of LAC:
 - (a) Cheque
 - (b) Payment Certificate
 - (c) Counter Signatures on Account Book
 - 3. After getting the signature on cheque by LAC, the same will be disbursed to the applicant alongwith payment certificate. The following documents will be obtained from the applicant:
 - (a) A photocopy of PAN Card or Form 16 as the case may be.
 - (b) Revenue Stamp of Rs 1/- affixing on receipt and signature of claimant on it.
 - (c) An entry of cheque is made in Register and get it signed from the applicant.
 - (d) Identity proof of all concerned at the time of release of cheque.
 - (e) Obtain signature of applicant on concerned documents to verify the correctness.
 - 4. The release of payment is subject to receiving of Payment from Land & Building Department/Requisitioning Department.
