FINAL ORDER

Applicants Smt. Savitri Devi and Sh. Randhir Singh R/o H. No. 40, Village Baprola, Nangloi, Delhi-110043 has applied before the Tribunal vide registration no. 21 (1989) dated 17/04/2014 complaining against their daughter-in-law Smt. Manju W/o Late Sh. Satish Kumar R/o H. NO. 40, 1st Floor, Village Baprola, Nangloi, Delhi-110043 under the Maintenance & Welfare of Parents & Senior Citizens Act, 2007.

Case called present the petitioners Smt. Savitri Devi and Sh. Randhir Singh and the Respondent daughter-in-law Smt. Manju. The petitioner stated that the Respondent Smt. Manju continues to be abusive and misbehave and have a threat perception to their life and property from Smt. Manju and her relatives i.e. mother, sisters and their husbands. The respondent Smt. Manju is very aggressive in her verbal deposition before the Tribunal and seems to be only interest in the property of the petitioner. Smt. Manju has also filed cases related to domestic violence etc..

Sufficient time was given to both parties to reach to a amicable mutually agreeable solution/agreement. Conciliation efforts were also made by the Tribunal members but all efforts were proved futile, due to non-cooperative/adamant attitude of Smt. Manju. Therefore, Tribunal decided to issue final orders as follows:-

1. Separate electricity and water connections to be provided by the Smt. Savitri Devi & Sh. Randhir Singh (Petitioners) to respondent Smt. Manju on first floor of the said premises H. No. 40, Village Baprola, Nangloi, Delhi-110043
2. The daughter and grandson of petitioner can visit them only on the ground floor of the property.
3. The relatives – mother, sisters etc. of Respondent Smt. Manju are to refrain from entering the property of the petitioner without his specific permission.
4. The Respondent Smt. Manju shall refrain from all kinds of misbehaviors, verbal or physical towards the petitioners and their daughter Ms. Savita and to improve their interpersonal relations.
5. The concerned DCP to ensure that the Senior citizens are safe and secure.
6. The concerned SHO to keep a vigil over life and property of the senior citizen and to render all possible help, whenever approached by the senior citizens.
