Sh. Jagram S/o Sh. Prabhatilal, R/o B-99, Ambika Enclave, Nihal Vihar, Nangloi, New Delhi-110041 has filed an application before this Tribunal under section 5 of the Maintenance & Welfare of Parents & Senior Citizens Act, 2007 complaining against his sons Sh. Premchand, Sh. Rajkumar, Sh. Bhagwandass, Sh. Niranjan Kumar, Sh. Nand Kishore, Sh. Deshraj and daughter-in-laws vide registration no. 1731 dated 02/04/2014 expressing threat, perception to his life and property and wanted vacation of his property from the respondent sons of their families.

After the conciliation efforts and, hearing all the parties and going through the documents in file, the Tribunal Orders are as under:-

1. All the sons are agreeable to pay the maintenance of Rs. 900/- per month as the maintenance amount to the petitioner by cheque by 10th of every month into the account no. 33846334269 of SBI Bank, Guru Harkishan Nagar in the name of Sh. Jagram and Smt. Ram Pyari.
2. Sub-Meters shall be installed in the portions occupied by sons and all of them shall pay their own share of water and electricity charges as per their consumption pattern.
3. All the parties shall refrain from abusive, threatening behavior towards each other and shall treat the parents with due respectful behavior.
4. The concerned SHO keep a vigil over life and property of the senior citizen and to render to all possible help whenever approached by the senior citizens.
