## ORDER 06/02/2014

This order shall dispose of fresh application made by the Senior Citizen Sh. Jalalluddin R/o A-665, J. J. Colony, Camp No. 2, Nangloi, Delhi-110041 against his son Sh. Nasir Ahmad R/o A-665, J. J. Colony, Camp No. 2, Nangloi, Delhi-110041 for non-compliance of Tribunals orders issued on 21/05/2013.

Notices were issued and the respondent appeared before the Tribunal. During the hearing on 10/09/2013 the respondent admitted that he had not paid maintenance to his father the petitioner.

Subsequently the petitioner Senior Citizen Sh. Jalalluddin appeared before the Tribunal a number of times and verbally deposed that the respondent son Sh. Nasir Ahmad had not complied with the tribunals orders of paying the maintenance.

In spite of repeated notices the Respondent has failed to appear before the Tribunal.

The harassed senior citizen has been running around for the last few months seeking justice.

Ab Julio share

The tribunal invokes Chaper-II, Clause V Sub Clause 8 of Maintenance of Parents and Senior Citizens Act, 2007 quote "children or relative so ordered fail, without sufficient cause to comply with the order, any such Tribunal may, for every breach of the order, issued a warrant for levying the amount due in the whole, or any part of each month's allowance for the maintenance and expenses of proceeding, as the case be, remaining unpaid after the execution of the warrant, to imprisonment for a term which may extend to one month or until payment if sooner made whichever is earlier" unquote.

As an exemplary punishment under the above mentioned clause of the maintenance act for non-compliance of the tribunals order. The Tribunal announces Jail Term of 15 days for the respondent Sh. Nasir Ahmad S/o Sh. Jalalluddin , R/o A-665, J. J. Colony, Camp No. 2, Nangloi, Delhi-110041.

The release orders of Sh. Nasir Ahmad shall be issued after the amount of Rs. 31500/- (Thirty One Thousand Five Hundred Rupee Only) i.e. amount due w.e.f. 1<sup>st</sup> of June, 2013 to 28<sup>th</sup> February, 2014 is deposited before the Tribunal in Cash/Demand Draft, in favour of the petitioner Sh. Jalalluddin and also a borned submitted that the maintenance amount shall be paid by him for the next two months and also subsequently.

The SHO to take the respondent Sh. Nasir Ahmad in the immediate custody and to submit a compliance report within two weeks from the date of issue of this order.
