Sh. Lala Ram Rathore S/o Late Sh. Balwant Singh R/o 223-A, Than Singh Nagar, Anand Parvat, New Delhi-110005 has applied before the Tribunal vide registration no. 303 dated 21/01/2014 complaining against his son and daughter-in-law Sh. Vijay Kumar and Smt. Varanda Thakur W/o Sh. Vijay Kumar, respectively for non compliance of Tribunals order dated 31/10/2013

Sh. Lala Ram had filed a complaint against Sh. Vijay Kumar and his wife Smt. Vrinda Thakur for misbehavior against him with the intention of grabbing his property no. 223-A, Than Singh Nagar, Anand Parvat, New Delhi-110005 and had also requested for maintenance. The

case was heard and the Tribunal had passed an order on 31/10/2013 giving relief to the petitioner by ordering maintenance etc.

Then the Petitioner Sh. Lala Ram again filed an application in end of January 2014 for non compliance of Tribunal's order on the part of the Respondent son Sh. Vijay Kumar and daughter-in-law Smt. Vrinda Thakur before the Tribunal.

The case was listed for 25/02/2014 and at the time of the hearing the younger son Sir. Dharmender who was supporting the petitioner father Sh. Lala Ram, informed the Tribunal that the petitioner father expired on 19/02/2014 after two days of hospitalization in Hindu Rao hospital and there was no foul play.

The Respondent son Sh. Vijay Kumar had not complied with the Tribunal's order and had neither paid any maintenance amount nor settled the electricity dues. The Tribunal was suddened to observe that the Respondent had no remorse for not having paid the maintenance amount or looked after the petitioner father in his twilight years though ordered by the Tribunal.

Due to the death of the petitioner, the Tribunal decides to close the case.
