They stated that their son and daughter do not contribute to the day to day expenses of the household and are misbehaving with the petitioners.

The Tribunal summoned the petitioners Sh. Mohan Lal alongwith his wife Smt. Chandra Kanta and respondent Ms. Leena and Sh. Rajiv and also the 2nd son Sh. Tarun was present who is supporting the petitioners.

The petitioners seem to be greatly influenced by their younger son Sh. Tarun, 29 years old, employed and wanting to study, further, on financial support from the parents, hence the enhanced financial requirement of the senior citizens, the same was explained and declined to the senior citizens. After conciliation efforts, it was observed and agreed upon

1. Respondent Sh. Rajan shall under take medical treatment for him and pay Rs. 4000/- pm as maintenance to the petitioner.
2. Respondent Ms. Leena is currently jobless and shall pay Rs. 2000/- pm as maintenance whenever she has a job.
3. Sh. Tarun shall pay Rs. 4000/- pm as maintenance. All are to pay maintenance amount as cheque by 10th of every month into the account of the petitioner.
4. All the family members shall improve their interpersonal relationships. All the siblings to refrain from taunting each other and be respectful to each other and the parents.
