FINAL ORDER

Sh. V. N. Srivastava R/o WZ-122, Plot No. 334 Chand Nagar, New Delhi-110018, has filed a case before this Tribunal under Maintenance And Welfare of The Parents And Senior Citizens Act, 2007 complaining against their sons Sh. Kuldeep Kumar and Sh. Sandeep Kumar vide registration No. is 1914 dated 11/04/2014 in which he stated that he wanted maintenance from his sons and a roof on his head in which he could live peacefully.

The petitioner Sh. V. N. Srivastava repeatedly stated that he wants to live with his younger son Sh. Pradeep Kumar only and wants maintenance only from his two respondent sons Sh. Kuldeep Kumar and Sh. Sandeep Kumar, who have a business of their own are financially well off.

There were lots of allegations and counter allegations between the parties. Unequal distribution of the property among the sons of the petitioner seems to be the underlying cause of this complaint.

Conciliation efforts were made, the tribunal decides to maintain the senior citizen and provide a roof over the senior citizens' head.

The Tribunal's Orders are as under:-

1. The two respondent sons Sh. Kuldeep Kumar and Sh. Sandeep Kumar shall pay maintenance of Rs. 5000/- per month each as the maintenance amount to the petitioner by cheque by 10th of every month into the account no. 11059316812 of SBI Bank, Tilak Nagar in the name of Sh. Vishambhar Nath Srivastava.
2. The two respondent sons Sh. Kuldeep Kumar and Sh. Sandeep Kumar will meet all the financial exigencies for treatment and any other related issue medical otherwise of the Senior Citizen.
3. All the parties shall refrain from abusive, threatening behavior towards each other and shall treat the parents with due respectful behavior.
4. The Senior Citizen Sh. V. N. Srivastava shall live with his youngest son Sh. Pradeep Kumar, who shall provide him food and with all the amenities life long.
