Petitioner mother Smt Kaushalya Devi with her, in her house and look after her petitioner mother.

In her fresh application filed before the Tribunal in Jan 2014 wherein the petitioner Smt Kaushalya Devi had mentioned that though she is having a pension of Rs.9,000/- per month and maintenance amount of Rs. 10000/- i.e. a total of Rs. 19000/- per month was not adequate to meet her day to day as well as medical expenses the petitioner Smt. Kaushalya Devi did not appear before the Tribunal due to her hospitalization and medical problems.

The respondent sons deposed before the Tribunal that the hospital expenses of the petitioner are being taken care of by the CGHS as she is a CGHS beneficiary. A conciliation officer was sent to the residence of the petitioner for investigation, conciliation and factual report.

At final hearing an MOU was reached upon between the widow daughter Smt. Manju Singh who is all along supporting her petitioner mother Smt. Manushalaya Devi and her brothers i.e. sons of the petitioner:- Sunil Bhardwaj, Anil Bhardwaj and Vimal Bhardwaj. The Tribunal's orders as under:-

- 1. Smt. Manju Singh r/o H. No. GH-5 & 7/323, Paschim Vihar, New Delhi-110087 shall continue to keep the petitioner mother Smt. Kaushalaya Devi in her house and look after all her day to day needs as well.
- 2. Maintenance amount payable by the three sons 654 i.e. Sh. Sunil Bhardwaj, Sh. Anil Bhardwaj and Vimal Bhardwaj shall be the same as ordered earlier in the Tribunals order dated 2505.2013.
- 3. Pension account of the petitioner mother Smt. Kaushalaya Devi will be handled by the eldest respondent son Sh. Anil Bhardwaj as there are allegations of misappropriation of account against the daughter Smt Manju Singh. The sons Sh. Anil Bhardwaj and Sh. Sunil Bhardwaj will

visit their petitioner mother every 10 to 15 days and help their sister Smt. Manju Singh whenever she seeks their assistance to look after the petitioner mother Smt. Kaushalaya Devi.

4. All the parties are advised to refrain from raising disputes against each other and to improve their interpersonal relationship, and live peacefully among themselves

The case is closed accordingly.
