FINAL ORDER

DATED 26/08/2014

Applicant Smt. Kulwant Kaur R/o House No. E-309, Raghubir Nagar, 25 Gaj, Delhi-110027 has filed an application vide registration no. 24 (2219) dated 02/05/2014 before the Tribunal for complaining against her son Sh. Jitender Pal Singh and daughter-in-law Smt. Manpreet Kaur under the Maintenance & welfare of Parents and Senior Citizen Act 2007.

Smt. Kulwant Kaur petitioner stated in her application that :-

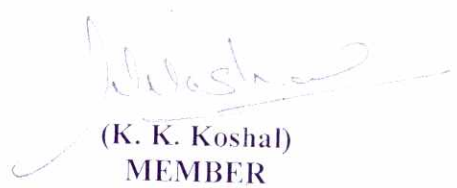
1. She wanted to build the house with the help of builder but the younger son Sh. Jitender Pal Singh and daughter-in-law Smt. Manpreet Kaur have not vacated the house.
2. She has also stated that her daughter-in-law Smt. Manpreet Kaur threatening her regularly use abusive language and she has quarrelsome attitude against Smt. Kulwant Kaur, Petitioner and regularly threaten her to implicate her in the false cases if her demands are not met to her satisfaction.



3. Petitioner wants maintenance from both of the sons, for her old age medical problems like dialysis etc.

As sufficient time was given to the petitioner and respondents with a view that they may come to a mutually agreeable solution amicably but all ~~effects~~ ^{efforts} of the Tribunal failed due to adamant attitude of respondent particularly Smt. Manpreet Kaur. Many proposals and written statements were received, and taken into consideration, therefore, Tribunals Orders as under:-

1. Both the sons Sh. Ravinder Singh and Sh. Jitender Pal Singh shall pay maintenance of Rs. 5000/- each and deposited in the account of the Smt. Kulwant Kaur, Petitioner before 10th of each month.
2. All parties are advised to improve their interpersonal relationship and live peacefully among themselves and all efforts be made to refrain from using threatening/abusive language towards the senior citizen.
3. SHO to keep a vigil over the life ^{and} ~~of~~ property of Senior Citizen.
